

**ELECTION COMMISSION NOW ISSUING NOMINATING PETITIONS FOR AUGUST 5, 2010 STATE PRIMARY AND COUNTY GENERAL ELECTION**

The Rutherford County Election Commission may now issue petitions for the August 5, 2010 State Primary and County General Election. Offices to be elected are: TN. Governor, U. S. House of Representatives (6th Cong. Dist.) 13th TN. Senatorial Dist., TN. House of Representatives (34th , 48th, 49th, and 62nd Districts), Republican and Democrat State Committeeman and Committeewoman, County Commission Districts 1-21, Rutherford County School Board (Zone 1, 4, and 7), and Rutherford County Road Board (Zone 2, 4, and 5). Qualifying deadline to turn in nominating petitions for persons seeking these offices is April 1, 2010 (12:00 Noon).

Qualified individuals may pick up nominating petitions M-F, except holidays, between 8-4:30 p.m. The information provided below reflects those individuals who picked up petitions, the office sought, and the date qualified.
